CHIEF EXECUTIVE'S COLUMN



hroughout its existence, the Institution has sought to be a forward looking professional institution, "seeking to identify and respond to the continuing and often fast changing professional needs of its members and the profession it serves". I believe that the Institution has been successful in this aim but is very much aware that such success must not lead to complacency. It has no right to expect or assume that those who are involved in the design, construction or maintenance of marine vessels and structures will automatically become or remain members of the Institution. The Institution must continually ask if it is providing the service which its members want today and in the future. It is as necessary for a professional

institution as it is for a commercial company to ask if it is providing value for money to its members and what they expect from their Institution and from their membership fee? Last year the Board initiated the Strategic Review 2050, to examine the role and activities of the Institution over the next 30 years, with the aim of identifying and responding to the continuing and often fast changing professional needs and expectations of its members and the profession it serves which are to be expected over the next three decades.

Key to this Review are, of course the views of the members, and Phase 1 of the Strategic Review, completed earlier this year, sought the views of the members through an extensive Membership Survey. This showed a high level of satisfaction with the role and activities of Institution, with 94% of members who completed the Survey considering that that the current Objectives were correct and would continue to be relevant for the foreseeable future. The results of the Membership Survey will form the basis of Phase 2 of the Strategic Review, which will determine any necessary changes to the means by which the Objectives are achieved.

This Phase of the Strategic Review, which is now underway, is being carried out by a number of Working Groups, comprising members of Council and other members of the Institution, each addressing one of the following Objectives, and seeking to identify how the Objective is achieved today and what changes will be required to continue achieving the Objective in 2050:

- Setting standards of professional competence and integrity.
- · Encouraging membership at all levels
- Enabling the exchange of technical information.
- Contributing its collective expertise to the benefit of society

Having identified such changes as might be required over the next three decades, the WGs will again seek the views of the members. I am sure all members will wish to support the Board in its intention to ensure that the Institution continues to be "a forward looking professional institution, always seeking to identify and respond to the continuing and often fast changing professional needs of its members and the profession it serves" which they would wish it to be.

RINA Crest

Do you know the meaning of the Latin inscription "Salum Et Carinae Pignora Vitae" on the RINA crest?

President of the Institution and Chairman of the Board of Trustees

Professor Richard Birmingham, BEng PhD CEng FRINA, was elected as the 33rd President of the Institution at the 2018 AGM. As President, he is also appointed as the Chairman of the Board of Trustees.

Professor Birmingham completed his BEng at Newcastle University in 1991 and subsequently completed his PhD studies at the University's Engineering Design Centre. After appointments as a Lecturer and Senior Lecturer at Newcastle University, he was appointed to his current position as Professor of Small Craft Design in 2002. He is also the principle Investigator of national and international collaborative research projects at Newcastle University, the focus for his research being sustainability and safety in the context of small craft, with a particular interest in the artisanal fishing vessels of the developing world.

He was the Head of the School of Marine Science and Technology 2007 – 2013, during which time he led the team which developed the proposal to run full time undergraduate programmes in marine technology in Singapore. This work culminated in the successful launch of the School of Marine Science and Technology's Singapore campus.

Appointments outside the University currently held by Professor Birmingham include Member of Technical Advisory Panel of the Royal National Lifeboat Institution, Member of Advisory Board of the University of Michigan and a Trustee of Blyth Tall Ship Charity. He is a past Non Executive Director of the Board of the Marine Management Organisation (the UK marine regulator).

Before his election as President, Professor Birmingham was a Vice President of the Council of the Institution, and was a member of the Board of Trustees.

Both before and during his academic career, Professor Bingmingham has had a strong interest and involvement with the small craft sector. Before embarking on his academic studies, he was both a fisherman and a boat builder, starting as an apprentice and ending as a Technical Director.

DATA PROTECTION

embers in Europe may be aware of the introduction of the General Data Protection Regulation (GDPR) which replaced the UK's Data Protection Act last month, and which now governs how the Institution may gather, hold and use personal data, ie data which can be used to identify the individual. The GDPR applies to all data on members held by the Institution, regardless of their country or nationality.

The GDPR has introduced a number of additional safeguards to the proper use of personal data. Principal amongst these is the requirement for members to agree to both the holding of data and the use to which it is put, ie to "opt in", rather than "opt out". The GDPR also requires greater security of personal data for which the Institution is responsible, regardless of where it is held, eg Headquarters, Branches etc. The GDPR also introduces more stringent requirements for the reporting of breaches of data security

and financial penalties for such breaches.

All members are entitled to receive the Institution's free eNewsletters, eg RINA News, *Ship & Boat International eNews* etc, providing information on technical developments in all sectors of te maritime industry and the Institution's activities. Members are asked on election and renewal of their membership fee to confirm that they wish to continue receiving the eNewsletters. Members may unsubscribe to all or any of the eNewsletters at anytime.

It continues to be the Institution's policy that personal data will not be passed to third parties without the member's permission, whether to an individual or organisation, except where required to provide membership services, eg posting of journals. Such organisations which do receive personal data are required to confirm that it will be handled in accordance with the GDPR, and only for the purpose for which it is provided.

Personal data passed to persons outside Headquarters authorised to hold such data, eg Branch Secretaries will be encrypted and password protected.

Members may check what personal data is held on them by the Institution by visiting their individual MyRINA page, and may remove any data other than that required to maintain their membership.

All Institution staff are required to report any breaches of security of personal data immediately. Members are requested to inform the Institution if they consider that their personal data has been improperly passed to or obtained by a third party.

The Institution will comply fully with the GDPR and continue to ensure the security and proper use of members' personal data. The Institution Privacy Policy may be accessed from the Home page of the institution's website. And queries about the use of members' personal data should be forwarded to the Chief Executive.

A meeting of the London Branch was held on 24 May when George Morrison, Regional Manager, West Europe, Emea-Anz Thordon Bearings, presented a paper 'Water Lubricated Propulsion – A Case For Full Acceptance'.

Water lubricated propeller shafts have been used since the earliest days of shaft driven propellers.

The paper explored that history, discussed the pros and cons of current methods in use and proposed the most environmentally sound and lowest cost solutions available for current installations. In addition, other onboard applications were presented with a view to removing the use of grease with maintenance free solutions.

RINA UAE organised a Branch meeting and technical paper presentation at Ball Room, Grand Excelsior Hotel, Dubai on 30 April 2018, when three papers were presented. The event was supported by Exalto Emirates.

TECHNICAL COMMITTEES

he Institution considers that it has a duty to make its collective expertise available for the wider benefit of society and the profession. It carries out this duty principally through its Technical Committees.

The Maritime Safety Committee

• all matters relating to the improvement of maritime safety.

Maritime Environment Committee

• all matters relating to the protection of the maritime environment, and marine renewable energy.

The IMO Committee

• representing the Institution in its capacity as an NGO at the International Maritime Organisation.

Maritime Innovations Committee

• identifying and assessing the impact of evolving technologies on the membership and profession, and determining how the Institution should address them.

Maritime Groups

Each of the Technical Committees has an associated Maritime Group, and each Maritime Group has an online Forum through which members will be kept up to date with the work of the Committees, and have the opportunity to both comment on that work and to propose items for consideration. Members may opt to receive notification of new items published on the Forums.

Technical Register

The online Technical Register of members' lists the experience and expertise of those members who are willing for their expertise to be called upon by the Technical Committees for specific issues. The Register is confidential.

Working Groups

Whilst the Technical Committees will have a core expertise across all vessel types and sectors, they will mainly carry out their work through ad hoc Working Groups, formed to address a specific issue which may have been raised by a member of the Committee or a member of the Institution through, for example, a Maritime Group.

Designatory Letters

embers may signify their membership of the Institution by the letters FRINA, MRINA, AMRINA, AssocRINA or StudentRINA after their names. In doing so, they demonstrate that they have achieved or are working to achieve the high standards of professional competence demanded by the requirements for membership, and which are recognised as such by the international maritime industry. By doing so, they also demonstrate their commitment to maintaining those standards through their continuing professional development, and their acceptance of the Institution's Code of Conduct. The Council has agreed that members may display the RINA crest on literature, website etc, under the following strict conditions:

- Members must request permission to use the crest, and statewhere it will be used.
- Only the version of the RINA crest provided by the Institution may be used. No variation or addition may be made to the crest.
- Members displaying the RINA crest are also required to display their membership of the Institution in text and by the use of the appropriate post-nominals.
- The RINA crest may only be displayed on a company website where the company is owned by the member or is a Corporate Partner member of the Institution.
- The RINA crest must not be used in a way as to state or imply the Institution's endorsement of a product or service provided by the member.

Skelton Men

Sir, I would be grateful if any of your members could provide me with information on the following SKELTON men who I am pretty sure were all trained at Thames Iron Works during the 19th Century as Naval draughtsmen/architects.

Thomas SKELTON 1810-1878 born Rotherhithe. Originally a shipwright but a draughtsman from the late 1840's when living at Limehouse. I suspect he was too early and probably too lowly a person for the RINA and is not a member of the Shipwright's Company.

His sons

Josiah SKELTON 1839-1910. Born Limehouse, Middlesex. Always referred to as a ship's draughtsman & worked for the Thames Iron Works Company. Spent many years the 1870's in Turkey instructing the Turkish Navy in the art of draughtsmanship/shipbuilding on behalf of TIW.

George SKELTON 1843-1887. Born Poplar Middlesex. Referred to as a naval architect & shipbuilder. Lived in Hull, Abingdon, Berks & West Ham.
