ANNUAL REPORT OF THE COMMITTEE 2017/2018

(Chairman's Report)

1. EXECUTIVE SUMMARY

- 1.1. This year 2018 marks the 18th Anniversary of the inauguration of the Joint Branch (JB) and the 60th anniversary of the inauguration of the IMarEST (previously IMarE) branch in Singapore.
- 1.2 Eleven committee meetings were held from January to November 2018. All meetings met a quorum.
- 1.3 The JB committee had another fruitful year of co-hosting technical talks with SNAMES, SMA at SP and CORE at NUS. Mr James Laybourne of DNV GL was selected by the committee as the best speaker and presented with a certificate by the IMarEST President during the annual dinner in October.2018.
- 1.4 Continuing on from previous years, two Members Nights were held at the Tanglin Club during the year. Both were very well attended and in both, a technical talk was arranged to share some interesting information in a pleasant atmosphere. These Member nights at the Tanglin Club have been very popular and well attended and same shall be continued also next year.

The 23rd annual Dinner along with the 60th Anniversary celebration of the IMarEST in Singapore was held on 19th October 2018 at the Ballroom of Regent by Four Seasons Hotel and was attended by 230 Members and guests. The event was graced by Cmdre Rob Dorey as the Chief Guest and Dr Sanjay Kuttan MD of SMI as Guest of Honour and the first Lifetime Achievement Awards of the Joint Branch were presented to six eminent Singapore members – 3 from RINA and 3 from IMarEST.

As agreed, from 2019, this number will be reduced to 1 Lifetime Achievement Award to a RINA member and 1 to an IMarEST member.

1.5 An annual grant fund of SGD 8365 (4971 GBP) has been received in November 2018 from IMarEST HQ which is less than the SGD 11058.53 received in 2017.

Part of the shortfall is due to drop in value of the pound, while the remaining is due to non-receipt of the Student grant of GBP 1000. A representation has been sent to HQ detailing our student activities in the current year and plans for Student activities in the next year along with a request to remit the student grant.

- 1.6 The expenditure in Technical Account again exceeded income but has improved slightly from last year. The audited Technical Account will be forward to both HQ after the AGM.
- 1.7 The ticketing system with Eventbrite continues to provide smooth results and this time has been used also for the AGM, as it helps in getting a close estimates of attendee numbers.
- 1.8. Fellows of IMarEST met with David Loosley Chief Executive of IMarEST at a Fellows Lunch on Jan 11th, 2018 at the Tanglin Club. The late Bob Maxell was awarded with an Honorary Fellowship during the event. Bob who was seriously ill, unfortunately passed away a few months later and is missed by all who knew him.





5. STUDENT ACTIVITIES (Coordinator: Chan Fann Howe)

Activities Organised in Year 2018.

- 5.1 The Joint Branch conducted road shows in Ngee Ann Polytechnic, Singapore Maritime Academy and Singapore Institute of Technology to promote the IMarEST and RINA to students who are pursing either a diploma or degree in marine maritime related qualifications.
- 5.2 The Student Coordinator established a group chat with the student representatives from the various Academic Institution to provide a communication channel between the JB and the Representatives for coordinating future activities.
- 5.3 Students were kept informed and invited to attend Joint Branch Technical Talks.
- 5.4 Thirty students from various Academic Institution were invited to attend the 60th Anniversary Dinner held in Regent Hotel, Singapore to enable interaction and gain insights from IMarEST and RINA members working in the local Maritime industry

Planned Student Activities for Year 2019

- 5.5 Students from various Academic Institution will be invited to present their Projects and Presentations to the IMarEST and RINA members through Joint Branch Events such as Members' Night or an arranged conference.
- 5.6 Select senior students would be invited for the social meets whereby they could interact with IMarEST and RINA members.
- 5.7 Apart from the usual Joint Branch Technical Talks, Special/Ad-Hoc Technical Talks can be arranged with the Academic Institution to tailor to Students Interest such as Big Data management, Unmanned System, 3D Printing as well as Sustainable future development. Students would be given an opportunity to interact with the speakers through a refreshment arranged after the Talk.
- 5.8 For the upcoming Singapore Maritime Week 2019, there is a plan to coordinate with Singapore MPA to invite the students to participate in activities such as Amazing Race, in which they would be exposed Singapore Maritime History, Present as well as future development.

- 6.1 This year, emails to members were sent in batches of 100, which though time-consuming was effective in preventing emails ending up in the recipient's spam folder.
