CHIEF EXECUTIVE'S COLUMN



2020 Annual Membership and Registration (where appropriate) Fees Renewal Notices will be forwarded next month by email, with posted copies only to members for whom no email address is held.

The recommended and preferred method of payment for members with access to a UK bank is by Direct Debit. Payment is taken when due on 1 January 2020, and no further action is required. This ensures that payment of membership fees is not overlooked, and avoids the need for me to write to members in June 2020, informing them that they are about to be removed from the Membership Roll and registration with the Engineering Council

for non-payment of fees, their journals having been stopped earlier. Direct Debit Mandate Forms are available from Headquarters. Members in China may pay directly into the Institution's Chinese bank account.

Membership fees may be paid online by all major credit cards. Payment can also be made by bank transfer or personal cheque drawn on a GBP, Euro, A\$, NZ\$, Can\$ or US\$ account, but members should remember that the bank will make a charge for transfer and ensure that the full amount due is transferred. Members experiencing administrative problems are asked to contact accounts@rina.org.uk as soon as possible after receiving the Notice.

All members are entitled to receive the printed and digital issues of *The Naval Architect, Warship Technology* and *Offshore Marine Technology* (digital only). Members have the option to receive the digital version only, with a corresponding reduction in membership fee. The financial saving to both member and the Institution apart, many members find this to be the most convenient method of receiving and reading the magazines, whether on a PC or tablet (using the RINA Publications App). Members receiving the digital issue have access to all archived issues. Members are requested to check their MyRINA page on the Institution's website before paying their 2020 Membership Fee, to ensure they are receiving the correct magazine version or to opt to receive the digital version only.

Members are also asked to review their standing order for magazines and the Transactions (the *International Journal of Maritime Engineering*, the *International Journal of Small Craft Technology*. Members should also decide if they wish to subscribe to *Ship & Boat International* and *Shiprepair & Maintenance*. I would urge all members who do not already do so to consider taking these magazines at little more than P&P cost only. They are first-class magazines and are widely acknowledged in the world maritime industry as leaders in their fields. More copies sent to members means larger circulations, which makes the magazines more attractive to advertisers, which increases the Institution's income, which means lower Annual Fees! Details of the magazines are on the website.

I would ask all members to check and update their personal details given on their MyRINA page. At any one time, up to 200 members' current addresses are not known, resulting in correspondence and publications being returned, and back numbers being forwarded when new addresses are notified. The additional administrative, postage and printing costs are not insignificant. A charge is also made for returning publications from outside the UK.

2020 Elections to Council

Tollowing the changes to the By Laws in 2019, the total number of elected Council members will be 40, comprising 30 Corporate members (Fellows and Members) and 10 Non Corporate members (Associate Members, Associates). Members' countries will be grouped into global Regions and the total number of Council members may be varied to ensure that each Region will elect at least one Corporate and one Non Corporate member of Council. The number of members of Council elected in each Class of membership from each Region will be in proportion to the number of Voting Members (All members, excluding Student Members, Junior Members and Corporate Partners) in the Region. Members of Council will be nominated from and elected by members in each Region. The 2020 Council elections will be in accordance with the changed composition. Members will be advised by email of the vacancies in their Region.

Members are invited to nominate Corporate Members and/or Non Corporate Members from their Region where there are vacancies. Nominations should include a Proposer and Seconder who are members of the Institution, and a brief CV of the nominated member. The agreement of the member should be obtained before making the nomination. Nominations should be forwarded by post or email, to arrive at Headquarters by 1700 GMT on 31 November 2019.

Election of the President

Reduction in membership and registration fees

embers who are no longer in gainful employment, who are over 60 years of age and have been a member for 20 years, are eligible for the retired rates of membership and registration fees. Members taking a Career Break for more than 6 months, eg family duties, illness, return to full-time education, may be eligible for a reduced

rate of membership and registration fees.

Members wishing to apply for the retired rate or Career Break reduction in membership and registrations fees should contact the Membership Department. Members applying for the retired rate(s) should confirm that they are no longer in gainful employment. Members applying for the Career Break reduction in fees

should state the reason and confirm that they intend to return to employment.

Members receiving the retired rate should inform the Membership Department if they return to gainful employment. Members receiving the Career Break reduction in membership and registration fees should re-apply annually on receipt of their Annual Fees Notice.

"Design For The Maritime Environment"

Environmental Considerations in the Design of Marine Vessels and Structures

Society expectation and regulation require that the maritime industry be fully sensitive to the environment through the reduction of gas emissions, contamination of the seas and more efficient use of sustainable resources. The thoughtful design and construction of marine vessels and structures can have significant influence in achieving these.

The Maritime Environment Committee has produced an aide memoire describing those aspects of marine vessels and structures that have an impact on the environment, and how that

impact can be mitigated through design. The Aide is intended to provide a broad overview of environmental design considerations and not a detailed reference to design and associated regulation.

he UAE Branch meeting and technical paper presentation was held on 12th March 2019 at Abu Dhabi. The event was held at Al Ain Ball Room, Royal Rose Hotel, Abu Dhabi. Three papers were presented during the event.

Mario Princevac, Head of Emirates Plan Approval Office (EPO), Bureau Veritas S A. Dubai presented paper on the subject *BV methodology for calculating FRP structures*. The paper covered calculation methodology and principles of Bureau Veritas Rules NR546 "Hull Composite Materials and Plywood, Material Approval, Design Principles, Construction and Survey" and associated software "ComposeIT". Local experience with projects and examples of software application were presented as well.

Mark Harvey, C.Eng., MRINA, Technical Manager, Gulf Marine Services, Mussafah, Abu Dhabi presented the paper *Asset Integrity, Implementation and Case Study* and spoke about implementing the principles of Asset Integrity Management to the GMS fleet, focus areas and presented a case study of effectiveness.

The third paper of the evening was presented by Rafid Qureshi, Ocean Power International LLC, Dubai about *Environmental Leadership in Bearing Systems*. The paper discussed features of Marine Bearing Solutions (Thordon) including Grease Free Rudder Bearings, Grease Free Deck Equipment Bushings, Sea Water Lubricated Propeller Shaft Bearings, System Components, Conversions and Ship Owner Benefits.

The paper presentations were very interesting with excellent interaction with attendees.

The event was attended by more than 40 persons consisting of branch members and invited guests. Rajesh Panicker, Branch Secretary opened up proceedings of the evening and welcomed the attendees. Mr Suman Nookireddi, MRINA introduced speakers and their topics.

1883-2013


riginally commissioned in 2013 for publication within the Ministry of Defence in 2013 to celebrating the 130th Anniversary of the Royal Corps of Naval Constructors, after relatively minor changes it now has the permission of the Ministry of Defence for open publication.

The book tells the story of the modern history of the RCNC since the Centenary history was published in 1983. It draws upon first-hand accounts and material from the annual RCNC Journal and from unclassified technical papers and official reports. The book charts the design, procurement and support of warships and their systems over the last two decades of the 20th century and the first decade or so of the 21st. It places these developments in the context of how the Ministry of Defence (MoD) organisation and warship acquisition and support have changed and the effect of these changes on the RCNC itself.
