ANNUAL REPORT OF THE COMMITTEE FOR THE YEAR 2018/2019 (Previously known as Chairman's Annual report)

1. Executive Summary

- 1.1. The year 2019 marks the 17th Anniversary since the inauguration of the Joint Branch (JB) in Singapore in 2002.
- 1.2 Eleven committee meetings were held from January to November 2019. All meetings met a quorum.
- 1.3 The JB committee had another successful year of co-hosting technical talks with SNAMES, SMA at SP and CORE at NUS. Mr Julien Boulland of BV was selected by the committee as the best speaker and presented with a certificate during the annual dinner in October.2019.
- 1.4 Continuing the practice of previous years, two Members Nights were held at the Tanglin Club during the year. Both were very well attended and in both, a technical talk was arranged to share some interesting information in a pleasant atmosphere. These Member nights at the Tanglin Club continue to be very popular and well attended and it is hoped that they will be continued also in future years.
- 1.5 The 24th annual Dinner & Conversazione was held on 18th October 2019 at the Churchill Room, Tanglin Club and was attended by 103 Members and guests. The event Mr Trevor Blakely Chief Executive of RINA as Guest of Honour. The second batch of Lifetime Achievement Awards of the Joint Branch were presented to two Singapore JB members, Mr Dorab Daruvala and Arun Dev, who were selected by an independent panel of judges.
- 1.6 An annual grant fund of est SGD 11,126 (6422 GBP) has been remitted by HQ in December 2019, which is higher than the SGD 10,350.43 received in 2018. This grant includes a special allowance of GBP 500 which was agreed with IMarEST HQ to cover expenses claimed by PRI assessors during the year.
- 1.7 To stop the recurring deficit of \$\\$ 2000 in the technical account every year, we negotiated a special rate with IMarEST Singapore office and shifted the Joint Branch's registered address from ASMI to IMarEST's Middle Road office during the year. This will save over \$\\$ 1000 /year in our registered office and admin fees.

We also discussed and agreed a fixed annual allowance with IMarEST HQ to cover travel and petty expense claims of PRI assessors, which were earlier being borne by us. With these two steps we expect that the technical account will break even or even show a slight positive balance from 200 onwards.

1.8. Committee members met Mr Trevor Blakeley Chief Executive of RINA over lunch at SPGG during his stopover in Singapore on 12 March 2019. Trevor again stopped over on 22nd March to attend our Members evening at Tanglin Club, where he gave a brief talk and interacted with members.

The undersigned met Mr David Loosely Chief Executive of IMarEST on 3rd Oct 2019 during an MOU signing between MPA and IMarEST at MPA HQ.

1.9 Road shows were organised by the Student Coordinator in Ngee Ann Poly, SMA and SIT to promote the Institute and Institution to Maritime Students. Students were invited to all the technical talks, and selected students also attended the annual dinner.

The Chairman, accompanied by Andrew Wong and Arun Dev gave a presentation on Joint Branch, RINA and IMarESt to Cardiff University SIRC Alumni on 22nd November 2019 at Sentosa.



6. Web Editor (Chan Fann Howe)

- 6.1 With the switch from Outlook to Gmail, emails to members were sent in batches of 500, which has significantly reduced the time required from 30mins to 10mins. IMarEST and RINA HQ has been providing us with updated list of members every quarter and our mailing lists have been kept updated due to this.
- 6.2 We have setup a dedicated Singapore Joint Branch web editor account for the IMarEST webpage. This allows web editor to send out events in the title of web editor instead as his/her name. In future, this account will be handed over to Council Member holding the position of Web Editor.
- 6.3 A significant number of bouncing emails are being observed. As we can only update addresses from the HQ lists, members are requested to keep their contact information updated, especially their email address.
- 6.4 Technical talks and other events registration are now regularly being done using Eventbrite, which is proving to be a dynamic and easy to use event hosting platform.
- 6.5 We are grateful to both IMarEST and RINA HQ IT teams, who have helped and supported the Joint Branch IT activities by promptly addressing any technical issues and giving timely feedback and suggestions.

8. Changes to Branch Constitution

The following changes moved in the 2018 AGM, were incorporated in the Branch constitution, after lengthy discussions (and some amendments) with IMarEST and after receiving approvals of RINA and the Singapore Registrar of Societies –

CLAUSE 4 MEMBERSHIP QUALIFICATIONS AND RIGHTS

4.2 Only members who are above 21 years of age shall have the right to vote and to hold office in the Society.

Replaced with

Cl 4.2 "Only Associate members, Members and Fellows, who are above 21 years of age shall have the right to vote, nominate as a proposer or seconder and to hold office in the Society. Other grades of Members can be co-opted into the committee but without voting rights."

CLAUSE 5 APPLICATION FOR MEMBERSHIP

5.1 A person wishing to join the Society should submit his particulars to the Secretary on a prescribed form.

Replaced with

Cl 5.1 "A person wishing to join the Society should submit his/her particulars to the membership committee of the respective parent body on a prescribed form."

5.2 A new member must be proposed and seconded by existing members. The Committee will decide on the application for membership.

Replaced with

Cl 5.2 "A new member while applying for membership must meet the requirements of the parent body. The membership committee of the respective parent body will decide on the application for membership."

CLAUSE 8 MANAGEMENT AND COMMITTEE

8.3 Names for the office-bearers shall be proposed and seconded at the Annual General Meeting, and election will follow on a secret balloted majority vote of the members. All office-bearers, may be reelected to the same or related post for a consecutive term of office. The term of office of the Committee, excluding the Chairman, Vice Chairman and Ordinary Committee Members, shall be one year. The Chairman, Vice Chairman and Ordinary Committee Members shall hold a two-year term of office. The term of office of the Treasurer shall be not more than two years.

Replaced with

Cl 8.3- names for the office bearers shall be proposed and seconded at the Annual General Meeting and election will follow on a secret balloted majority vote of the Members.

The term of office of the committee, excluding the Chairman, Vice Chairman and Ordinary Committee Members, shall be one year.

The Chairman, Vice Chairman and Ordinary Committee Members shall hold a two year term of office.

All office bearers, excluding the Chairman and Treasurer, may be re-elected to the same or related post for a consecutive term of office.

The Chairman cannot be re elected as Chairman for a consecutive term but can be elected to any other position in the committee. He may be re elected as Chairman, only after a gap of at least one term, from his previous tenure as Chairman.

Similarly, the Treasurer cannot be re elected as Treasurer for a consecutive term, but can be elected to any other position in the committee. He may re elected as Treasurer, only after a gap of at least one term, from his previous tenure as Treasurer..

9. Lifetime Achievement Awards

The joint Branch's second set of Lifetime Achievement Awards were presented by Mr Trevor Blakely to two members selected by an independent panel of judges. The recipients of the 2019 awards were Arun Dev (FRINA & FIMarEST) and Mr Dorab Daruvala (IMarEST). Presentation of these awards will be continued at future annual dinners.
