Proposed Amendments to the Constitution

First Proposed Amendment -

Clause 2 - PLACE OF BUSINESS

"Its place of business shall be at "C/O ASMI, 30 Tuas Avenue 10, #07-01 Freight Links ELogistics Technopark, Singapore 639150" or such other address as may subsequently be decided upon by the Committee and approved by the Registrar of Societies. The Society shall carry out its activities only in places and premises which have the prior written approval from the relevant authorities, where necessary."

"Its place of business shall be at "C/O ASMI, 9 Jurong Town Hall Road, #04-03, Trade Association Hub, Singapore 609431" or such other address as may subsequently be decided upon by the Committee and approved by the Registrar of Societies. The Society shall carry out its activities only in places and premises which have the prior written approval from the relevant authorities, where necessary."

Second Proposed Amendment -

Clause 16 - DISPUTES

16.1 In the event of any dispute arising amongst members, they shall attempt to resolve the matter at an Extraordinary General Meeting in accordance with this Constitution. Should the members fail to resolve the matter, they may bring the matter to a court of law for settlement.

16.1 In the event of any dispute arising amongst members, they shall attempt to resolve the matter at an Extraordinary General Meeting in accordance with this Constitution. Should the members fail to resolve the matter, they may bring the matter to a court of law **in Singapore** for settlement.

Proposed amendments to the Constitution were adopted with the consent of two-thirds of the voting members present at the AGM with 20/28 voted in favour. It was proposed that the consent of the parent bodies and the prior sanction of the Registrar of Societies be obtained for the amendments to be implemented as above.

The following motion was filed for new committee's consideration.

A/P Arun Kr Dev -

- 1. The year 2018 will be 60 years of IMarE (now IMarEST) which started in Singapore in 1958. The JB did a huge event in 2008 (Golden Jubilee). There were 400 guests at the event. One Minister also attended. The incoming JB Council may take a plan/initiative to observe the Platinum Jubilee on this 60 years.
- 2. There are many outstanding Naval Architects and Marine Engineers in Singapore, who are member of the JB and many of them are now retired. Their contributions are immense. It is now time that JB introduce "life time achievement award" to deserving Naval Architects and Marine Engineers of JB annually at the Annual Conversazione and Dinner. It will be good that in 2018 (Platinum Jubilee Year), at least 10 Naval Architects and 10 Marine engineers are given such awards by the JB Council.
- 3. JB also should take an initiative to organize a Conference in 2019 on a new theme like Specialized Ships where new initiatives like Sustainability, LNG, Autonomous ships, Digital application, Big Data, etc. can be included.
- 4. It is noted that all communication from the JB do not originate from the Council Hon. Secretary, which should be the normal way for any professional body. It has been practiced for many years in the Singapore JB. For some reasons, it is not happening now. The incoming Council should take note of this anomaly.

Chairman thanked A/P Arun Kr Dev for the above motion filed and recommended for the in-coming committee to deliberate and take necessary actions that are in accordance to the Constitutions of the JB.

The following comments and questions were raised by the members and responded by the Chairman during the AGM.

- Comment A/P Arun Kr Dev complimented Mr Ng Chun Wee, Technical Chairman for the organisation of technical talks in 2017.
- Q A/P Arun Kr Dev and Mr David Kinrade queried if the costs associated with the Professional Reviews are to be claimed back from IMarEST and whether it should be claimed directly from IMarEST Asia Pac.
- A Chairman explained that the costs incurred are only for the reimbursement of transportation or out-of-pocket expenses but agreed that the committee would explore ways to claim back the costs from IMarEST. It is noted that members who assisted in the Professional Reviews have contributed their own time and preferred to claim directly from JB as claiming from IMarEST Asia Pac can be a lengthy process.
- Q Mr David Kinrade queried on the cost of holding AGM at the Tanglin Club as compared to the former venues.
- A Chairman explained that although the cost of holding AGM and other networking events at the Tanglin Club is about double as compared to former venues but members have expressed their preference to hold such events at the Tanglin Club.
- Q Mr Kenneth Kee asked if there is any outstanding collections from the Annual Dinner.
- A Hon. Treasurer replied that collection of outstanding is completed and accounted in the Financial Report.
- Q Mr Ling Kooi Hui suggested that JB can make use of the technical and social activities platforms to promote closer industry networking and development across JB's members.
- A Chairman welcomed the suggestion and highlighted that the technical and social events organised in 2017 have also this objective in mind and encouraged greater participation of members at such events.
- Comment Mr David Kinrade commented that JB can work closer with IMarEST's Mr David Kelly on student activities. Dr Zhou Yili (Course Chair at SP) shared that all his students are student members of IMarEST. The annual
