#### 4.1 Safety Techniques Workshop

- 4.1.3 With reference to funding, **SWa** said that it should be not driven by financial gain but seen as a duty of the professional institution.
- 4.1.4 **TBu** suggested seeking the financial support of a sponsor from industry.

- 4.2.1 The Committee noted the report of the sinking of the ship *El Faro* (*concise version*). Some members expressed the need of reading the full report. **RGe** therefore e-mailed the link to the Committee.
- 4.2.2 **ABa** asked the members to point out the items of this report relevant to the discussions of the committee.
- 4.2.3 It was mentioned that the extreme angle of heel had prevented the appropriate launching of the LSA.

4.2.4 It was decided that a procedure on how the Committee should deal with these reports must be prepared and agreed. **GWi** offered to prepare a draft document.
