1. Minutes of the Previous AGM

The Chairman welcomed the duly elected members to the RINA London Branch Council.

5. Constitution

The Committee proposed to change an item on the Branch Constitution. The proposal covered the issue of retiring members after their three year term of membership. Currently the constitution says that such members shall not be eligible for immediate re-election except those members who may be co-opted to serve out the unexpired term of a member who resigns, provided they have been duly nominated.

As many members move around on business related matters, and we know that LR members have generally been relocated to Southampton, it is apparent that nominations to Council may well be effected.

As a consequence, and in order to ensure a strong Council, the following amendment was proposed

"Retiring members of the Branch Council shall not be eligible for immediate re-election except if there are vacancies due to new applications being low or those members who have been co-opted to serve out the unexpired term of a member who has had to resign, and in all cases providing they have been duly nominated".

The meeting accepted the proposal.
