CHIEF EXECUTIVE'S COLUMN



y now, most members should have received their 2014 Annual Subscription Renewal Notices. For the first time, Renewal Notices have been sent by email, with posted copies only to members for whom no email address is held. This gives a significant saving in printing and postal costs, but feedback on this new arrangement would be welcome.

For members with access to a UK bank, the preferred method of payment is the Direct Debit. No further action is required by those members with Direct Debits set up. [I would strongly urge other members to consider this method of payment for future years. It ensures that payment of membership fees is not overlooked, and avoids the need for me to write to members in

June 2014, informing them that they are about to be removed from the Membership Roll for non-payment of fees, their journals having been stopped earlier. Direct Debit Mandate Forms are available from Headquarters] Members are reminded that resignations cannot be accepted from members with fees outstanding. Their membership record will show them as lapsed for non-payment of fees.

For other members, it is recommended that the facility to pay by credit card be used. Payment for all RINA conferences, publications and merchandise, as well as membership and registration fees, can be made by all major credit cards. Members may also make their payment by credit card online if there is no change to the amount shown on the Renewal Notice, using the secure link from www.rina.org.uk/Membership. Payment can also be made by bank transfer or personal cheque drawn on a GBP, Euro, A\$, NZ\$, Can\$ or US\$ account, but members should remember that the bank will make a charge for transfer and ensure that the full amount due is transferred.

I would be grateful if members would check the personal details on the Renewal Notice and inform Headquarters if there are any errors or changes. At any one time, up to 200 members' current addresses are not known, resulting in correspondence and journals being returned, and back numbers being forwarded when new addresses are notified. The additional administrative, postage and printing costs are not insignificant. A charge is also made for returning journals from outside the UK. Change of address can be notified by letter, fax, email or through the RINA Website at www.rina.org.uk/Membership. May I also ask that members inform Headquarters of their email addresses, either by email to hq@rina.org.uk or with their Annual Subscription payment details. Email is now used as the preferred method of communication with members, including the RINA News e-newsletters.

This year, members will be required to subscribe to the printed versions of *The Naval Architect, Warship Technology* and *Offshore Marine Technology*, or continue to only receive the digital version (with access to archived editions). This change is reflected in a lower membership fee for all members..

Members are also asked to review their standing order for journals and the Transactions (the *International Journal of Maritime Engineering* and the *International Journal of Small Craft Technology*). Members should also decide if they wish to subscribe to *Ship & Boat International* and *Ship Repair & Conversion Technology*. I would urge all members who do not already do so to consider taking these journals. They are all first-class journals and are widely acknowledged in the world maritime industry as leaders in their fields. More copies sent to members means larger circulations, which makes the journals more attractive to advertisers, which increases the Institution's income, which means lower Annual Fees!

Letters to the Editor

John Shaw Helyer, 1857-1919

Sir; I would be grateful for any information which members might have about John Shaw Helyer, who designed the ten-ton cutter, Tammie, built in Southampton in 1898, which I now own.

Helyer was born on the Isle of Wight in 1857. He worked for a time at the Royal Dockyard, Portsmouth. He was a member of RINA in the late 19th century.

Helyer was also an architect who designed buildings, practising in Bournemouth for a time. Soon after 1900 he and his wife moved to Vancouver. Here he seems to have been very successful, obtaining some major public buildings commissions including the famous Dominion Trust Building [1908–10]. His son Maurice joined the practice in 1910.

J S Helyer designed Tammie for George R Ratsey of the famous Cowes sailmakers. She was built by Field and Co at Itchen Ferry, Southampton. Tammie later belonged to the celebrated yacht designer Charles Nicholson and was sailed regularly until about ten years ago. Under her new owner Tammie is being overhauled to sail again. She is on the National Maritime Museum's small boat register under number 2370.

UK National Women in Engineering Day 2014

Currently less than 10% of the UK engineering workforce are women, and with a large skills gap in the sector looming, and the additional need for a more diverse engineering workforce, it has never been more important to encourage girls to choose a career in engineering.

RINA - Lloyd's Register Maritime Safety Award

The Institution believes that the safety of both the seafarer and the maritime environment begins with good design, followed by sound construction and efficient operation. Whilst naval architects and other engineers' involved in the design, construction and operation of maritime vessels and structures do not have a patent on such issues, nonetheless their work can make a significant contribution.

The Institution also believes that it has a role to play in recognising achievement of engineers' in improving safety at sea and the protection of the maritime environment. Such recognition serves to raise awareness and promote further improvements.

The Maritime Safety Award is presented by the Institution, in association with Lloyd's Register, to an individual, company or organisation which has made a significant technological contribution to improving maritime safety or the protection of the maritime environment. Such contribution can have been made either by a specific activity or over a period of time. Nominations may be made by any member of the global maritime community, and are judged by a panel of members of the Institution and Lloyd's Register. The Award will be announced at the Institution's Annual Dinner.

Nominations are now invited for the 2013 Maritime Safety Award. Individuals may not nominate themselves, although employees may nominate their company or organisation.

Shanghai Branch

embers of the Shanghai Branch and other members of the maritime community in Shangha attended a Technical Meeting on 3 December 2013, at which D Wijendra, Manager Ship Emergency Response Service, Lloyd's Register, gave a very interesting presentation on "The Ship Emergency Response Service 1982 – 2013".

Established more than 30 years ago, the Ship Emergency Response Service (SERS) is the largest and most experienced emergency response service, supporting 500 plus clients aroubd the world covering more than 3100 vessels. The SERS procedures and format were first developed in the mid 1980s, prior to any legislation or industry requirements and continues to be refined as part of LR's continuing support to the industry.

In his presentation, Mr Peiris described the SERS system and the evolution of emergency response requirements and legislation, illustrated the experience gained over the past 30 years, and outlined some thoughts for the future.
