CHIEF EXECUTIVE'S COLUMN



ay I take this opportunity of the first issue of RINA Affairs in 2018 to wish all members a belated Happy New Year (less belated for Chinese members!).

Over the past year I have again had the pleasure of meeting members (and some soon to become members) in some of the countries where the Institution is represented at all levels in universities, industry and maritime organisations. My visits to some of the 70+ universities where the Institution has links and the many companies in all sectors of the maritime industry where members work has left me in no doubt as to the standing which the Institution enjoys in the international maritime community.

The Institution has members in 97 countries, demonstrating conclusively that the Institution is truly an international organisation. The decision of those involved at all levels in the design, construction, maintenance and management of marine vessels, from Australia to Azerbaijan, to become members is confirmation that membership provides an internationally recognised demonstration of the highest standards of professional competence. Their membership also confirms the value which they place upon the Institution's international publications and conferences, providing the relevant and up to date information on developments across all sectors of the global maritime industry which is essential to maintaining that competence.

Membership Survey

There has been an excellent response to the Membership Survey - both the quantity and quality of suggestions.

The Survey showed a high level of satisfaction with the role and activities of Institution. 94% of members who completed the Survey considered that that the current Objectives were correct and would continue to be relevant for the next 10-15 years, ie:

- Setting standards of professional competence and integrity.
- Encouraging membership at all levels
- Enabling the exchange of technical information.
- Contributing its collective expertise to the benefit of society

However, the Survey also demonstrated to review the means by which these Objectives would be achieved and what changed would be needed to reflect the changes in the maritime industry and the professional needs of the members.

Key benefits of membership were shown to be the internationally recognised professional qualification, demonstrating the achievement of the highest standards of professional competence and integrity, and the access to up to date, credible information on information on developments in the maritime industry.

The survey showed a number of themes that the Institution will need to address if it is to meet the needs and expectations of the members, the maritime industry and society. These include:

- Outward facing
- Create an open, welcoming and outward looking face to all possible stakeholders in order to increase RINA's traction across the sector

- Adopt new and developing means of digital communication to provide the Membership with efficient information dissemination and learning platforms

- Conferences & Publications
- Focus on the future challenges for the sector with a wider range of events, improve the accessibility of conferences to members and encourage high quality of papers
- Employers
- Make RINA's activities more valuable to members' current and prospective Employers in order to improve recognition and increase in support for members fees

These themes will be addressed over the next year.

Comments on the coverage of the Institution's journals were particularly welcome and valuable, and will be addressed the their Editors.

Damaged Ship IV

Call for Papers

Recent incidents at sea have shown that investigations and understanding of the behaviour of damaged ships are as important as ever. Significant progress has been made over the last 10 years but there still remain numerous scientific and practical challenges.



After any major accident it is imperative to rapidly quantify the damage, assess damage stability and the residual strength of a vessel. Damage stability appraisal must also consider the likelihood of progressive flooding, the effect of the mass and motion of flood water within the vessel, capsizing probability and effect of waves on stability. There is a need to consider both the global strength capability of the ship structure and the local residual strength of damaged and buckled plating and the effect of flooding on internal structure.

NEWS FROM THE TECHNICAL COMMITTEES

Maritime Environment Committee

"The Maritime Environment Committee was formed following a review of the Institution's standing Technical Committees. The Committee is tasked by the Council with making the collective technical expertise of the Institution available for the benefit of the profession and society by contributing to the protection of the maritime environment and the sustainable use of resources.

In its first meetings, the Committee has sought to list those aspects of the design, construction and operation of marine vessels and structures which can have an impact on the maritime environment and the use of resources, identify what that impact is and determine what actions might be taken to mitigate it. In due course, this list will serve to prioritise the use of the Committee's resources. It will also provide an "aide memoire" for those members and others in the

maritime industry who are involved in the design, construction and operation of marine vessels and structures, as a means of improving their knowledge and understanding of how to protect the maritime environment and make more sustainable use of resources.

Maritime Innovation Committee

Also formed following a review of the Institution's standing Technical Committees, during its early meetings the Maritime Innovations Committee has discussed at length the areas in which the innovative and emerging technologies will have an impact on the industry, the profession and the Institution across all sectors in the immediate future and long term. The following themes have been identified:

- Design and Manufacturing including Materials and Coatings
- Hydrodynamics and Propulsors
- Power Generation and Energy Management
- Operations, Maintenance and Training
- Safety and Environment incl. Human Factors and Legislation
- Autonomy, Data, Digital and Cyber
- Business and Economics

Education and Research were considered to cut across all themes and sectors.

The Committee has now established a number of individual sub-groups for each theme looking at the emerging technologies which could have an impact on the Institution's members.
