## CHIEF EXECUTIVE'S COLUMN



By now, most members should have received their 2012 Annual Subscription Renewal Notices. For members with access to a UK bank, the preferred method of payment is the Direct Debit. No further action is required by those members with Direct Debits set up. [I would strongly urge other members to consider this method of payment for future years. It ensures that payment of membership fees is not overlooked, and avoids the need for me to write to members in June 2011, informing them that they are about to be removed from the Membership Roll for non-payment of fees, their journals having been stopped earlier. Direct Debit Mandate Forms

are available from Headquarters] Members are reminded that resignations cannot be accepted from members with fees outstanding. Their membership record will show them as lapsed for non-payment of fees.

For other members, it is recommended that the facility to pay by credit card be used. Payment for all RINA conferences, publications and merchandise, as well as membership and registration fees, can be made by all major credit cards, members may also make their payment by credit card online if there is no change to the amount shown on the Renewal Notice, using the secure link from www.rina.org.uk/Membership. Payment can also be made by bank transfer or personal cheque drawn on a GBP, Euro, A\$, NZ\$, Can\$ or US\$ account, but members should remember that the bank will make a charge for transfer and ensure that the full amount due is transferred.

I would be grateful if members would check the personal details on the Renewal Notice and inform Headquarters if there are any errors or changes. At any one time, up to 200 members' current addresses are not known, resulting in correspondence and journals being returned, and back numbers being forwarded when new addresses are notified. The additional administrative, postage and printing costs are not insignificant. A charge is also made for returning journals from outside the UK. Change of address can be notified by letter, fax, email or through the RINA Website at www.rina.org.uk/Membership. May I also ask that members inform Headquarters of their email addresses, either by email to hq@rina.org.uk or with their Annual Subscription payment details. Email is now used as the preferred method of communication with members, including the RINA News e-newsletters.

Members are also asked to review their standing order for journals and the Transactions (the *International Journal of Maritime Engineering* and *the International Journal of Small Craft Technology*). Members should also decide if they wish to receive *Ship & Boat International* and *Ship Repair & Conversion Technology*, in addition to *The Naval Architect, Warship Technology* and *Offshore Marine Technology* and Supplements which they receive free of charge. I would urge all members who do not already do so to consider taking these journals. These are available to members at a reduced cost of £39 for the *IJME* (four issues per year), £26 for the *IJSCT* (two issues per year), £40 for *S&BI* (six issues per year) and £25 for four issues of *SR&CT*, free of p&p. They are all first class journals and are widely acknowledged in the world maritime industry as leaders in their fields. More copies sent to members means larger circulations, which makes the journals more attractive to advertisers, which increases the Institution's income, which means lower Annual Fees!

# Simplified Scantlings Calculator Method

he International Council of Marine Industry Associations (ICOMIA) supported by the International Marine Certification Institute (IMCI) has launched a scantlings calculator which uses a series of easy-to-use spreadsheets in order to provide a calculation method to help and encourage builders to comply with ISO (Small Craft) Scantling standard 12215 Part 5.

Particularly used for the EU Recreational Craft Directive (RCD) compliance, builders face a number of challenges when self-assessing scantlings for craft of hull length less than 12-meters in all design categories. In order to comply with RCD requirements, builders use the 'Harmonised Standard' which provides the 'Presumption of Conformity', however the complex nature of these documents often force them into to hiring a consultant or seeking a way to bypass the proof of compliance with the RCD.

In response to these issues, ICOMIA's Technical Committee initiated a study (sponsored by IMCI), and upon approval from ISO, commissioned Southampton Solent University to develop a series of Excel spreadsheets designed to be used in conjunction with the ISO standard and specifically for use by self-certifying builders for whom 12215 Part 5 may be too daunting or time consuming.

Regards David Harley Chairman RINA Scottish Branch extensive physical large scale model test is performed with disconnectable turret mooring for application in the arctic summer environment in shallow water. The arctic environment with ice conditions require turret mooring system for the vessel with the capability that the platform is removable in emergency conditions e.g., approaching icebergs. Motion behaviour of the vessel in waves with 100% turret mooring is determined physically in tank test. For wave conditions in another field location in the world with clear water, the vessel is also needed to be designed with 100% conventional mooring system. Hence, the effect of different kinds of mooring system, including 50% vessel and 50% turret mooring, on vessel behavior is studied. Key results on the comparison of test vs. analysis results are presented. These results are considered of immense interest and value to the Oil and Gas industry.

The presentation was attended by 52 people and was followed by a very interactive Q&A session.
