CHIEF EXECUTIVE'S COLUMN



By now, most members should have received their 2013 Annual Subscription Renewal Notices. For members with access to a UK bank, the preferred method of payment is the Direct Debit. No further action is required by those members with Direct Debits set up. [I would strongly urge other members to consider this method of payment for future years. It ensures that payment of membership fees is not overlooked, and avoids the need for me to write to members in June 2013, informing them that they are about to be removed from the Membership Roll for non-payment of fees, their journals having been stopped earlier. Direct Debit Mandate Forms are available from Headquarters] Members are

reminded that resignations cannot be accepted from members with fees outstanding. Their membership record will show them as lapsed for non-payment of fees.

For other members, it is recommended that the facility to pay by credit card be used. Payment for all RINA conferences, publications and merchandise, as well as membership and registration fees, can be made by all major credit cards. Members may also make their payment by credit card online if there is no change to the amount shown on the Renewal Notice, using the secure link from www.rina.org.uk/Membership. Payment can also be made by bank transfer or personal cheque drawn on a GBP, Euro, A\$, NZ\$, Can\$ or US\$ account, but members should remember that the bank will make a charge for transfer and ensure that the full amount due is transferred.

I would be grateful if members would check the personal details on the Renewal Notice and inform Headquarters if there are any errors or changes. At any one time, up to 200 members' current addresses are not known, resulting in correspondence and journals being returned, and back numbers being forwarded when new addresses are notified. The additional administrative, postage and printing costs are not insignificant. A charge is also made for returning journals from outside the UK. Change of address can be notified by letter, fax, email or through the RINA Website at www.rina.org. uk/Membership. May I also ask that members inform Headquarters of their email addresses, either by email to hq@rina.org.uk or with their Annual Subscription payment details. Email is now used as the preferred method of communication with members, including the RINA News e-newsletters.

This year, Renewal Notices will reflect members' choice of whether to continue to receive The Naval Architect in printed and digital format, or to receive the journal in digital format only and enjoy a lower cost of membership. If the former, a subscription to *The Naval Architect* will appear on the Renewal Notice.

Members are also asked to review their standing order for journals and the Transactions (the International Journal of Maritime Engineering and the International Journal of Small Craft Technology). Members should also decide if they wish to receive Ship & Boat International and Ship Repair & Conversion Technology, in addition to The Naval Architect, Warship Technology and Offshore Marine Technology and Supplements which they receive free of charge. I would urge all members who do not already do so to consider taking these journals. They are all first class journals and are widely acknowledged in the world maritime industry as leaders in their fields. More copies sent to members means larger circulations, which makes the journals more attractive to advertisers, which increases the Institution's income, which means lower Annual Fees!

Chief Executive

President's Invitation Lecture London, 21 November 2012

he 2012 President's Invitation Lecture was given by Eduardo Autran, the Executive Manager of Supply and Logistics Petroleo Brasileiro SA Petrobras, who described the challenges faced by both Petrobras and the Brazilian maritime industry.

Over 150 representatives of the global maritime industry heard an information packed lecture in which Mr Autran outlined spending plans for both the upstream and downstream spending from 2012 to 2016, including a fleet expansion programme that will see the Petrobras fleet expand from 287 ships at the end of 2010 to adding a further 146 ships by 2017.

As a result of the major investment programme Mr Autran said that Petrobras will double its oil production and its crude

oil reserves, it will increase its refining capacity by 70% and see a 50% increase in its market.

Petrobras would like to use local suppliers for the development of vessels and equipment, but Mr Autran explained that the local yards and other offshore industry lacked the expertise on its own to meet the massive demand from Petrobras.

Mr Autran said that there were already 47 yards in operation in Brazil with a further 11 yards under construction. Some 62,000 workers were directly employed in the industry, which has an orderbook totalling 6.8m dwt, and orders for 19 offshore oil platforms and a further 21 deepsea rigs.

The major challenges are to increase the "local content" for these orders and for that there is a need for human resources, people with the skills to meet the demand from an expanding industry.

Mr Autran answered a wide range of questions from the audience, after which those attending enjoyed dinner at One Whitehall Place. Photographs taken at President's Invitation Lecture may be viewed at "2012 President's Invitation Lecture- Photos".

33ft launch Quest

Sir: I am searching for information regarding the design of a 33ft launch (Quest), designed and built in the 1950's by a well know Picton boat builder of the day, Roger Carey.

Quest, a 33ft vessel of trawler design was built here in Waikawa and received such wide admiration that the plans were subsequently sent to the boatbuilding yard of James N Miller & Sons Ltd in the small village of St Monans Scotland. The designer later named this design Fifer and it is believed that as many as 50 Fifers

of varying lengths were built, some for well-known identities of the day such as Michael Bentine of the Goons fame.

I also understand that this particular design (and the designer's name), were later submitted to the Royal Institute of Naval architects, and that subsequently, Roger Carey was admitted as a member of the Institute, a great honour in his life.

My purpose in writing to the institute today is simply to enquire if there could by any chance, be any information in the Institutes files, records or archival systems that could shed any light on this particular vessel i.e. design drawings, details, specifications or copies of the original submitted plans perhaps?
